The reinforcement can be accomplished in as little as 60 minutes a day broken down into 2 to 3 or even 5, 15-minute sessions per day per dog. Duration of training: \*Please make sure you are scheduling classes each and every week starting the week after the 1st session. \*Your sessions will no longer be valid after 21 days after the end date That gives you three make up sessions. The only way that I will accept more than 3 make-up sessions is if you have a note from a Veterinarian that I can confirm with the Animal hospital or Animal Clinic that they work at. If your dog has a medical condition that keeps them from training you can transfer the lessons over to another dog whether they live at your home or not, or you can wait until the dog is healthy again no matter the time it takes and we will then continue the lessons.
